

RECORD OF ORDINANCES

Ordinance No. 13 - 10

Passed MAY 3, 2010

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ADVERTISE FOR BIDS FOR THE VILLAGES 2010 STREET RESURFACING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the Village plans to resurface the following streets within the Village corporation limits, and

WHEREAS, the Streets and Sidewalks Committee recommends the following streets be considered for repaving in Fiscal Year 2010:

- Base Bid:** 1.) 7th Street
From: Cherry Street To: Superior Street
- 2.) 10th Street
From: Buckeye Street To: West Terminus
- 3.) Main Street
From: 3rd Street To: 4th Street
- 4.) Library Drive
From: West @ 6th Street and side lot
- 5.) Library Side Lot
- 6.) Lincoln Street
From: 4th Street To: North Terminus
- 7.) Alley
Between Wilson and Cherry Streets and North of 4th Street
- Alternate** 1.) West Street
From: 8th Street To: RR bed

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, does hereby authorize the Village Administrator to advertise for bids for the Village's 2010 Street Resurfacing Program.

SECTION 2. All bids shall be in accordance with detailed specifications on file in the Office of the Village Administrator. The Village shall reserve the right to accept any bid which it considers most advantageous to it, or reject any and all bids.

SECTION 3. It is found and determined all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance shall take effect at the earliest date allowed by law to provide a vital service of pavement resurfacing during this construction season.




