ORDINANCE SETTING RENTAL AND QUARRY ADMISSION FEES FOR VETERAN'S MEMORIAL PARK; AND DECLARING AN EMERGENCY.

WHEREAS, the Advisory Board for Veteran's Memorial Park has made recommendations for admission and rental fees to be charged in 2013 and thereafter;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO, THAT:

SECTION 1. That beginning January 2013 and thereafter the following shall be the fees charged for Shelter House Rental and Quarry Admission:

Shelter House

\$75.00	Large
\$40.00	Small
\$150.00	Corporate

Quarry Fees

Residents:

\$40.00	Family Pass / yearly
\$35.00	Individual Pass / yearly

Within School District

\$50.00	Family Pass / yearly
\$40.00	Individual Pass / yearly

Outside School District

\$75.00	Family Pass / yearly
\$60.00	Individual Pass / yearly

SECTION 2. That Fee collections for the Shelter House and Quarry, and Quarry Pass Applications, shall the responsibility of the Park Director.

SECTION 3. It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

SECTION 4. That this Ordinance constitutes an emergency measure because charging an adequate amount of Fees for use of the Shelter House and Quarry is necessary for the immediate preservation of the public peace, safety, and welfare of our citizens. This ordinance shall be in full force and effect immediately after its passage by the Mayor.






