AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ADVERTISE FOR BIDS FOR PHASE 6 OF THE NORTHWEST AREA STORM SEWER IMPROVEMENT PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, the Village Council did pass ordinance 22-12 to prepare and submit an application to participate in the Ohio Public Works Commission Program.

WHEREAS, the Village has received funding through a loan in the amount of Two Hundred Thirteen Thousand Dollars Four Hundred and Fifty Dollars (\$ 213,450.00) from the Ohio Public Works Commission (Issue II).

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, does hereby authorize the Village Administrator to advertise for bids for Phase 6 of the Northwest Area Storm Sewer Improvement Project.


SECTION 2. The project consists of the installation of storm sewers along Buckeye Street beginning at the north terminus of the Phase 5 Project, and proceeding north to 17<sup>th</sup> Street. The project also includes the reconstruction of this portion of Buckeye Street, to restore the pavement after damage from construction operations.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


