AN ORDINANCE AUTHORIZING THE FISCAL OFFICER TO TRANSFER SIXTEEN THOUSAND THREE HUNDRED DOLLARS (16,300.00), FROM THE CAPITAL IMPROVEMENT FUND (403), INTO MAJOR PROJECTS D-1 FUND (405), AND DECLARING AN EMERGENCY.

WHEREAS, the Village has debt payment due to the Ohio Public Works Commission from the Northwest Sewer Phase I and Phase II made within the Village.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO.

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby authorize the Fiscal Officer to transfer \$16,000.00 from the Capital Improvement Fund (403), into Major Projects Fund (405), as follows:



SECTION 4. This Ordinance shall be in full force from and immediately after its passage.


