AN ORDINANCE AWARDING A BID TO CASH SERVICES, LLC. OF 1141 N.GENOA-CLAY CENTER ROAD, GENOA, OHIO 43430, FOR A BASE BID IN THE AMOUNT OF ONE HUNDRED TEN THOUSAND, FIFTY- EIGHT DOLLARS, AND FIFTEEN CENTS (\$110,058.15), AND ONE (1) ALTERNATE BID IN THE AMOUNT OF SEVEN THOUSAND, SEVEN HUNDRED FORTY-FIVE DOLLARS AND NINETY CENTS (\$7,745.90), FOR THE VILLAGE'S PHASE 6 OF THE NORTHWEST AREA STORM SEWER IMPROVEMENT PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, the Village Council did authorize the Village Administrator to advertise for bids for the Phase 6 of the Northwest Area Storm Sewer Improvement Project (Ordinance 16-13).

WHEREAS, Cash Services, LLC, 1141 N. Genoa-Clay Center Road, Genoa, Ohio 43430, was the lowest and best bid.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby award a bid to Cash Services, LLC of 1141 N. Genoa-Clay Center Road, Genoa, Ohio 43430, in the amount of \$110,058.15 base bid, and an alternate bid in the amount of \$ 7,745.90 .

SECTION 2. That the Village Administrator is hereby authorized to enter into, and execute a contractual agreement with Cash Services, L.L.C, of 1141 N. Genoa-Clay Center Road, Genoa, Ohio 43430, for Phase 6 of the Northwest Area Storm Sewer Improvement Project.






