

RECORD OF ORDINANCES

Ordinance No. 17-14

Passed 6/16, 2014

AN ORDINANCE AUTHORIZING THE FISCAL OFFICER TO TRANSFER TWENTY-ONE THOUSAND FIVE HUNDRED DOLLARS (\$21,500.00), FROM THE WATER FUND (601), INTO THE OWDA WASHINGTON STREET - FIFTH STREET WATERLINE PAYMENT FUND (304), AND DECLARING AN EMERGENCY.

WHEREAS, the Village has its annual debt payment due to the Ohio Water Development Authority from water distribution improvements made on Washington Street, and Fifth Street within the Village.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby authorize the Fiscal Officer to transfer (\$21,500.00) from the Water Fund (601) into the OWDA Washington Street-Fifth Street Waterline Payment Fund (304) as follows:

SECTION 2. It is found and determined all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. The passage of this Ordinance as an emergency measure is necessary for the immediate preservation of the public peace, health, safety, and welfare in order to permit the Village of Genoa to meet established payment deadlines.


SECTION 4. This Ordinance shall be in full force from and immediately after its passage.


