AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ADVERTISE FOR BIDS FOR THE VILLAGES 2014 STREET RESURFACING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the Village plans to resurface the following streets within the Village corporation limits, and

WHEREAS, the Streets and Sidewalks Committee recommends the following streets be considered for repaving in Fiscal Year 2014:

The scope of work includes the resurfacing of Washington Street and Court Street, and the full-depth cement stabilization and resurfacing of Industrial Drive including the placement of approximately 400 cubic yards of asphalt, 325 square yards of full depth pavement repair, 2400 square yards of cement stabilization and other related work.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, does hereby authorize the Village Administrator to advertise for bids for the Village's 2014 Street Resurfacing Program.

SECTION 2. All bids shall be in accordance with detailed specification on file in the Office of the Village Administrator. The Village shall reserve the right to accept any bid which it considers most advantageous to it, or reject any and all bids.

SECTION 3. It is found and determined all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


SECTION 4. This Ordinance shall take effect at the earliest date allowed by law to provide a vital service of pavement resurfacing during this construction season.
