

RECORD OF ORDINANCES

Ordinance No. 22-14

Passed 9/12, 2014

AN ORDINANCE RETAINING BRIAN J. BALLENGER, ATTORNEY AT LAW, OF 3401 WOODVILLE ROAD, SUITE C, NORTHWOOD, OHIO 43619, AS VILLAGE SOLICITOR, FOR A PERIOD OF TWO YEARS, AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Genoa Council is authorized by the Ohio Revised Code to provide legal counsel, for the Village, and for any department or official thereof, and

WHEREAS, this Council wishes to provide legal counsel in the best interest of the public peace, health, safety and welfare of its citizens; and

NOW THEREFORE, BE IT ORDAINTED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO:

SECTION 1. That the Mayor and Fiscal Officer of the Village of Genoa are hereby authorized and directed to contract with Brian J. Ballenger, Attorney at Law, of Northwood, Ohio to serve as Village Solicitor for a period of two (2) years, commencing on September 2, 2014, and ending on September 2, 2016.


SECTION 2. That this Council of the Village of Genoa, Ottawa County, does hereby agree to retain Brian J. Ballenger as Village Solicitor under the following terms: One Hundred Thirty-Five Dollars, (\$135.00) per hour for all legal services provided to the Village, reimbursement of all expenses including travel, and payment of P.E.R.S.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberation of this Council, or any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


