

# RECORD OF ORDINANCES

Ordinance No. 09-15

Passed April 20, 2015

## AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ADVERTISE FOR BIDS FOR THE VILLAGE'S WATER BOOSTER PUMP STATION IMPROVEMENTS, AND DECLARING AN EMERGENCY.

WHEREAS, The Village plans to make improvements to its Water Booster Pump Station, and

WHEREAS, the Village Administrator recommends the scope of work to include installing two (2) 15 hp variable frequency drives, removal of existing hydraulic actuated pump check valves, two (2) pump control valves, pipe insulation, and miscellaneous demolition work.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, does hereby authorize the Village Administrator to advertise for bids for the Village's Water Booster Pump Station Improvements.

SECTION 2. All bids shall be in accordance with detailed specification on the file in the office of the Village Administrator. The Village shall reserve the right to accept any bid which it considers most advantageous to it, or reject any and all bids.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of it's committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements of the Village of Genoa, and the State of Ohio.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the public peace, health, in order to assure that the Village of Genoa can advertise for bids and award a bid prior to the current refuse contract expiring, and avoid a disruption in the collection of refuse and recyclables through the Village, and shall be in full force and effect from and immediately after its passage.


