ORDINANCE 21-2016

AN ORDINANCE AWARDDING A BID TO HENRY W. BERGMAN, OF 218 E. 9TH STREET, GENOA, OHIO 43430, FOR THE RESURFACING AND SEALING OF VILLAGE STREETS, IN THE AMOUNT OF (\$105,579.60) FOR THE VILLAGE'S 2016 STREET RESURFACING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the Village Council did authorize the Village Administrator to advertise for bids for the 2016 Street Resurfacing Program (Ordinance 19-16).

WHEREAS, Henry W. Bergman, Inc. 218 E. 9th Street, Genoa, Ohio 43430, was the lowest and best bid.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby award a bid to Henry W. Bergman, of 218 E. 9th Street, Genoa, Ohio 43430, in the amount of \$105,579.60.


SECTION 2. That the Village Administrator is hereby authorized to enter into, and execute a contractual agreement with Henry W. Bergman, Inc. 218 E. 9th Street, Genoa, Ohio 43430, for the 2016 Street Resurfacing Program.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


