ORDINANCE 27-2016

ORDINANCE AMENDING THE GENOA MUNICIPAL CODE SECTION 923.11, TITLED METHOD OF PAYMENT; CHARGE FOR LATE PAYMENT; AND DECLARING AN EMERGENCY.

WHEREAS, the Genoa Utility committee has reviewed the current code sections relating to utility charges and has recommended changes to the municipal code;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO, THAT:

SECTION 1. That the Genoa Municipal Code Section 923.11 shall read as follows:

923.11 METHOD OF PAYMENT; CHARGE FOR LATE PAYMENT

(a) The sewer service charge or rental provided in this chapter shall be payable monthly at the office of the Utility Billing Department or, at the option of the Village Administrator, may be made payable at the same time and place as water bills.

(b) In addition to the charge or rental determined according to the rate specified herein, a further charge of ten percent of such amount to determined shall be added thereto in case of failure to make prompt payments. The total thus obtained shall be the sewerage service charge or rental in each such case.

(c) The period within which payment shall be made in order to be classified as a prompt payment shall be determined by the Village Administrator, and shall be expressed through the rules or regulations which are authorized by this chapter to be made for the purposes hereof.

(d) When any check or other negotiable instrument used in the payment of any sewer service charge or rental due pursuant to this chapter is dishonored, an additional charge of forty dollars (\$40) per dishonored item shall be added to the bill of the person or entity owing the same.

SECTION 2. It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

SECTION 3 That this Ordinance constitutes an emergency measure because updating the Genoa Municipal Code to reflect current method of payment and charge for late payment of utilities is necessary for the immediate preservation of the public peace, safety, and welfare of our citizens. This ordinance shall be in full force and effect immediately after its passage by the Mayor.
