## ORDINANCE 45-2017

AN ORDINANCE PROVIDING FOR SEWER ASSESSMENTS UPON LOTS AND LANDS IN THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO, VILLAGE SEWER SYSTEM FOR THE 2017 TAX YEAR; AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO:

SECTION 1. That to pay for Sewer Assessments in the Village of Genoa, Ottawa County, Ohio, Village sewer system, shall be assessed upon lots and lands as described herein, for the year 2017, as may be determined by the Ottawa County Auditor to produce the sums as indicated from the lands listed below:

SECTION 2. It is found and determined all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance constitutes an emergency measure in order to meet the requirements of Ohio revised Code, Section 727 requiring special assessments be certified to the County Auditor by the second Monday in September annually.
