## ORDINANCE 54-2017

AN ORDINANCE PROVIDING FOR THE PAYMENT OF THE ENTIRE COST OF VILLAGE PROVIDED HEALTH COVERAGE FOR THE VILLAGE ADMINISTRATOR, KEVIN GLADDEN; AND DECLARING AN EMERGENCY.

WHEREAS, the Personnel committee has recommended that the Village pay the entire cost of health care coverage for Village Administrator Kevin Gladden.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO, THAT;

SECTION 1. That the Village of Genoa shall pay the entire cost of the Village provided health care coverage for Village Administrator, Kevin Gladden, commencing January 1, 2018. That Personnel Committee shall review this portion of the compensation package for the Village Administrator after three years.


SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

SECTION 3. That this Ordinance constitutes an emergency measure because updating the compensation of the Village Administrator is necessary for the immediate preservation of the public peace, health, safety and welfare of our citizens. This ordinance shall be in full force and effect immediately after its passage by the Mayor.
