Chemtrol Inc., will do the striping of Main Street for \$85.00/mile. It is estimated that there is approximately 1-1/2 miles of street to be done. will take about 25 gallons of paint per mile. The total expense for this project will be \$350.00 maximum.

It was asked that Council promote the Park Levy.

Ordinance No. 21-82 was read for the second reading.

Delton Jessee will take pictures for the ID Cards after Council, at the Police Station.

It was discussed as to Council's wishes concerning the second metting on the water system. After Hope talks to Kelly Frye, the BPA and Council will meet before another meeting is scheduled with the Commissioners.

Jack Jones, of Poggemeyer Engineering, will check the sewer plant for an update of capacity.

Barry Morrison presented Resolution No. 24-82, ADOPTING A BUDGET FOR THE VILLAGE OF GENOA FOR THE FISCAL YEAR 1983. Barry Morrison moved that Resolution No 24-82, be passed. It was asked if there were any suggestions for the use of Federal Revenue Sharing money for the year 1983. There were no comments on this subject.

Steve Mayer and Jerry Neff recommended that Council hire Rex Diebert to fill the position open between the BPA and the Street Department. It was their recommendation that his wages start at at least \$5.00/hr. Gladys Donley moved to accept the above recommendation, seconded by John Harbal. Pat Harbal pointed out to Council that qualified people will not work for the amount of money the village pays.

Pat Harbal recommended that Rosemary Stettler be hired in the village income tax office. She has bookkeeping experience but no knowledge of taxes. She recommended that Mrs. Stettler's starting wage be \$3.58/hr.

The lease on the village owned farm property was discussed. Mike Despones moved to extend Bill Bauer's lease on the farm property for one more year, at \$200.00/month.
