COUNCIL AND MAYOR HARBAL MET AT 7:15 PM SO AS NEWLY ELECTED COUNCIL MEMBERS ROBERT BAIRD AND EILEEN McLEAR, AND RE-ELECTED COUNCIL MEMBERS JOHN BOWER AND ROBERT SKILLITER COULD BE SWORN IN BY MAYOR HARBAL.

THE REGULAR COUNCIL MEETING WAS CALLED TO ORDER BY MAYOR HARBAL WITH THE PLEDGE TO THE FLAG AT 7:30 P.M. CLERK/TREASURER CHERYL BARTOW CALLED THE ROLL: MR BOWER, MR MOTTER, MRS DONLEY AND MR SKILLITER ALL PRESENT. ABSENT WERE MR VERKIN AND MR MILLER.
