THE REGULAR MEETING WAS CALLED TO ORDER BY MAYOR JOHN HARBAL WITH THE PLEDGE TO THE FLAG AT 7:30 P.M. CLERK/TREASURER CHERYL BARTOW CALLED THE ROLL: MR BOWER, MRS McLEAR, MR BAIRD, MRS DONLEY, MR SKILLITER AND MR MOTTER ALL PRESENT.

MR BOWER MOVED TO APPROVE THE MINUTES AS WRITTEN AND MR BAIRD SECOND. ROLL CALL VOTE: MR BOWER, MRS McLEAR, MR BAIRD, MRS DONLEY, MR SKILLITER AND MR MOTTER ALL YEAS (6)

ENGINEERS REPORT: NO REPORT

ADMINISTRATORS REPORT: MR GRISWOLD PRESENTED A WRITTEN REPORT TO COUNCIL.

MAYORS REPORT: THE MAYOR ASKED CONCIL TO APPROVE THE REAPPOINTMENT OF DENNIS SLOTNIK TO THE ZONING BOARD. MR SKILLITER MADE A MOTION TO APPROVE THE REAPPOINTMENT OF MR SLOTNIK, MR BOWER SECOND. ROLL CALL VOTE: MR BOWER MRS McLEAR, MR BAIRD, MRS DONLEY, MR SKILLITER AND MR MOTTER ALL YEAS (6)

MARK A. MORRISON OF 205 11TH STREET, CO OWNER OF THE HARDWARE ADDRESSED COUNCIL CONCERNING THE DEADLINE COUNCIL HAD GIVEN HIM ON RESOLVING THE PROBLEM OF THE CONDITION OF THE HARDWARE. HE STATED THAT THEY SHOULD KNOW SOON IF THE HARDWARE IS SOLD. MR MOTTER MADE A MOTION TO EXTEND THE DEADLINE UNTIL THE FIRST MEETING IN MARCH, SECOND MR SKILLITER. MR BOWER EXPRESSED A CONCERN OVER THE LENGTH OF TIME AND SUGGESTED THAT THE DEADLINE BE SET FOR THE NEXT MEETING.
