INSURANCE

Insurance rates for Paramount, as of November 1st, 2003, have increased 6.78% or \$9,852.00 and office visits went up from \$5 to \$10, vision up 4% or \$386.00 monthly, dental is up 9% or \$921.00 monthly. We have our liability coverage which doubled this year from \$70,000 to \$140,000. We are going to stay with Paramount for now. As of December 1st we will be paying these rates but will be shopping around for new liability policies. Medical Benefit/Cost Analysis pamphlet is on file in the Clerk/Treasurer's office.
