Mr. Gladden stated that Northwest Storm Sewer Phase VI is about 80% complete; Washington Street Phase II has had some engineering changes and utility changes that will push back construction to next year. Mr. Gladden reported that Washington Street Phase III scored low and will probably not be funded. ADMINISTRATOR'S REPORT Mr. Gladden presented a written report. Mr. Gladden reported that there are three Ordinances for First Readings concerning tap fee increases on the agenda. The Varough property has been cleared, all that needs to be done is the capping of the

wells.

Mr. Bittner asked about the wells.

Mr. Gladden stated they were drilled for the clean up and must now be capped.

Mr. Gladden updated Council on the backhoe; the old one is not feasible to be repaired, as it would be ten to eleven thousand dollars. A new backhoe can be leased for four years with a trade in of the present one being used as a down payment.

Mr. Brinkman presented paid bills of \$232,794.75. Payroll was \$88,106, \$10,623 to United Health for insurance, \$107,353 to AMP for electric and \$10,572 to Waste Management for trash hauling.

Mr. Gladden reported that the company installing gas lines had hit the water line to the park office, it has been repaired temporarily. The employees will be removing and storing items from the park over the next couple of weeks.
