Mr. Schettinger, a representative of Harbor Manufacturing Company, was present at Council meeting to discuss the sale of Municipal Bonds from the State of OHio. Genoa must ask the State of Ohio to issue the bonds by passing a Resolution. Hope Niehausmyer presented Resolution No. 18-79 providing A RESOLUTION REQUESTING THE ISSUANCE OF BONDS OF THE STATE OF OHIO PURSUANT TO ARTICLE VIII, SECTION 13 OF THE OHIO CONSTITUTION AND CHAPTER 165 OF THE OHIO REVISED CODE, TO FINANCE THE EXPANSION OF AN INDUSTRIAL FACILITY WITHIN THE BOUNDARIES OF THIS MUNICIPAL CORPORATION FOR HARBOR MANUFACTURING COMPANY, INC. AND DECLARING AN EMERGENCY.

Six (6) Yeas, and no (0) Nays. The motion passed. The Resolution was then read the first and second times by title only. The Resolution was then read the third time in fill. John Harbal presented two (2) quotations on the purchase of oil for the alleys His committee is considering the asphalt content. The lowest bid was thirty cents (30¢) a gallon with 18% ash content. He will work with the Street Commissioner to decide where the alley oil will come from. John Harbal also reported that the 1976 Ford Dump Truck needs repairs. The Street Committee will check to see if Ford is recalling this truck for loss of power. John Harbal also said that the backhoe is also in need of repairs.

Eric Hise moved to purchase a syde bar mower for the Street Department. The cost not to exceed \$200.00. The motion was seconded cy John Fletcher.
