Engineer Ray Saneholtz reported on the progress of the combined sewer inspection. A meeting with the sewer committee is tentatively planned for April 27, 1987.

Administrators report: Mr. McConn requested motions authorizing the village Administrator to submit a preapplication to the Ohio Water Development Authority to determine eligibility for sewer and treatment financing and motion by council to oppose hidden taxes by the federal government on gasoline taxes to the village local governments and to express our concerns to Senator Howard Metzenbaum and Representative Delbert Latta. Additionally a Resolution accepting the Road Crossing permits for the county, prepared by Peck Shaffer and Williams regarding the Water take-over and a motion authorizing the proper notification to property owners and the subsequent certification to the county ORC 735.29 of delinquent utility bills for liens against the property taxes.

Clerk-Treasurers report: Barbara Smith reported on the installation of the Budgetary accounting and presented a financial report for the month of March taken from the computor.

Park Board Mr. Skilliter reported on the request for the tractor from the Park Board.

Zoning Mr. Wepler reported a meeting will be April 16, 1987. Mayor Despones asked if any one wished to address council.

Committee reports

Streets - Mr. Miller commented on the trees being cut down and

the cold patch put down by the street department

Water - Mr./ Bower reported on the meeting on March 30, 1987 attended by property owners with their concern of over the deposit to be made by rentors for utilities. They have agreed to be responsible for payment of bills in a step to control delinquencies. Mr. Cottrell is to prepare a contract for the property owners to sign at the turn-on.

Sewer - Mr. Verkin reported he will meet with Mr. Ray Saneholtz and go over the maps.

Electric - Mr. Miller will present Ordinances 27-87 and 28-87. There will be an electric rate study of the system and maping.

Finance Mr. Skilliter reported on the meeting Thursday April 2.1987 where the bids for the police car and tractor for the Park were reviewed. Additionally a meeting with the income tax review board at which plans were laid to get the records current.

Safety - Mr. Verkin will present bids from Genoa Motors and Oregon Ford for the police car. Mr. Bower asked that it be recorded that Mr. Cottrell stated Mr. Bower has no conflict of interest in discussing the bid of Genoa Motors for the police car. Mr. Cottrells legal opinion regarding the bids are that the bids are not the same. Genoa Motors bid states Crown Victoria, 1987 4 door deliver date of 45-60 days. Total Vehicle/fees \$11,676.81. Oregon Ford 1987 Full size police cruiser 4 door sedan deliver date 120 days after award. Total cost \$11,072.81. Mr. Skilliter stated that in view of the bills for repair on the police car of almost \$1100 during March that the shortest period of time for delivery is a prime consideration, considering our immediate need.

Maintenance. Mrs. Donley inquired as to the plans for moving the police department to into the old income tax office. Insurance Mr. Harbal stated he had talked to Mr. Sprouse and that Mr. Sprouse was to get information to council. Mr. McConn stated he had had a discussion with Mr. Sprouse that he would be writing a letter to council or Mr. Harbal.
