The roller is working perfectly.

Medical Insurance information has been received and quotes should be available to the Insurance committee in the very near future. Information is being gathered on a Vac/All machine which is badly needed.

Proposed dates for Town Hall day will be August 26-27. The race will possibly be at 9 am and down Main and Washington Streets. There is possibility the C.C. will be in to replace the ceiling of the W.R.C. hall which has fallen in.

It will be necessary to get with finance committee and discuss including the cost with the new sewers.

AdHoc- Skilliter stated there are meetings this week on Town Hall
