STREETS-MCLEAR REPORTED SHE DID NOT HAVE THE MINUTES OF THEIR SEPTEMBER 13TH MEETING, BUT THEY HAD A MEETING WITH THE SAFETY COMMITTEES AND DISCUSSED SIDEWALKS WHICH HAD TO BE COMPLETED BEFORE THE NEW ONES COULD BE CONSTRUCTED, PAINTING OF SCHOOL CROSSWALKS, THE TIME FOR THE RED LIGHT AT 13TH STREET TO COME ON AND GO OFF AND THE RESPONSIBLITY OF GETTING THE CHILDREN TO AND FROM SCHOOL. SHE ALSO STATED THERE WAS A PROBLEM WITH CROSSING GUARDS AT MAIN STREET SINCE THEY WOULD NOT BE ABLE TO BE VIEWED BY SCHOOL PERSONNEL.
