Also present were Garth Reynolds, Village Administrator, Brian Ballenger, Village Solicitor and Charles Brinkman, Fiscal Officer.

APPROVAL OF MINUTES

Minutes of the June 7, 2010 meeting were presented.

Mr. Lewis stated he had a couple of changes. On page 1, after Ordinance 18-10, add "Esq." to Ernie Cottrell, also under Mayor's Report, Line 3, add "Esq." to Ernie Cottrell.

Mr. Lewis stated that Line 2, Administrator's Report, "ne" should be "new". And on Page 4, Line 1, change "McCoy" to McCaughey" in both places.

Mr. Brown stated that under Personnel Committee, Line 5, change "May" to June"; and under Administrator's Report, Line 25 change "is" to "his".

Mayor stated that under Administrator's Report; Line 2 change "Me." to "Mr."

Written report was presented.

Mr. Reynolds stated the No Parking sign for West Ninth Street have been installed; also, Jake Hasselbach has completed the Basic Level 1 electric training at Amp, remote meters for Book 16 are being installed, notification of block grant for repairs to Senior Center front doors and a curb ramp has been approved by the Ottawa County Commissioners, and are in the process of getting quotes for the signs in the front of Town Hall and Administration building.

Mr. Lewis asked if the no parking on W Ninth was to be on both sides as "No Parking" signs were posted only on the north side. Mr. Reynolds stated he would look into this.

Mr. Brown stated the Ordinance read both sides. Signs will be ordered and installed.

Mayor turned the meeting over to representatives of Sprouse Insurance. Derrick and Mike Sprouse presented an overview of the Public Entities Pool that the Village of Genoa is a part of. Mr. Lewis asked if we are in a pool, no individual policy but with the whole group. Mr. Lewis asked if the pool was just government entities. Mr. Mike Sprouse stated just municipalities as the townships were in another pool.

Mr. Hise asked about Article 9 and if the pool would pay because of a signature that was not authorized to sign the contract.

Mr. Mike Sprouse stated that it probably was no problem because it was a member of the pool. Mr. Ballenger stated he would get a letter to change the signatures to Derrick Sprouse. Derrick Sprouse stated he had contracts signed by the Mayor and Mr. Reynolds.
