ORDINANCE # 05-2023

ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO A SOLID WASTE AGREEMENT FOR THREE (3) YEARS BEGINNING APRIL 1, 2023 WITH WASTE MANAGEMENT OF OHIO, INC.; AND DECLARING AN EMERGENCY.

WHEREAS, It is necessary for the Village of Genoa to enter into a Solid Waste Agreement with Waste Management of Ohio, Inc. for the purpose of extending the term of the service provider agreement; and revising pricing; for a period of three (3) years beginning April 1, 2023.

WHEREAS, The Utility Committee for the Village of Genoa does hereby set a new rate of \$16.80 per month for solid waste pick-up commencing April 1, 2023.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO THAT:

SECTION 1. That the Council of the Village of Genoa, Ottawa County, Ohio hereby authorizes the Village Administrator to enter into a contract for Solid Waste Agreement with Waste Management of Ohio, Inc.; and attached hereto as Exhibit A. (The Contract)

SECTION 2. It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and Section 121.22 of the Ohio Revised Code.

SECTION 3. This ordinance shall take effect as an emergency measure necessary because providing solid waste removal is necessary to protect the health, safety and welfare of our citizens and shall be in full force from and immediately after its passage.
