ORDINANCE 10-2019

**AN ORDINANCE AUTHORIZING THE VILLAGE OF GENOA TO PARTICIPATE
IN THE DEPARTMENT OF TRANSPORTATION COOPERATIVE PURCHASING
PROGRAM FOR THE YEAR 2019, AND DECLARING AN EMERGENCY.**

WHEREAS, Section 5513.01 (B), provides for the opportunity for counties, townships, municipal corporation conservancy districts, park districts, created under Chapter 1545 of the Ohio Revised Code, port authorities, regional transit authorities, transit boards, state universities or colleges to participate in contracts of the Ohio Transportation for the purchase of machinery, materials, supplies or other articles.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO:

SECTION 1. That the Village Administrator requests authority in the name of the Village of Genoa, as to participate in the Ohio Department of Transportation contracts for the purchase of machinery, materials, supplies or other articles which the department has entered into pursuant to Ohio Revised Code Section 5513.01 (B).

SECTION 2. That the Village Administrator is hereby authorized to agree in the name of the Village of Genoa to be bound by all terms and conditions as the Director of Transportation.

SECTION 3. The Village Administrator is hereby authorized to agree in the name of the Village of Genoa to directly pay vendors under each such contract of the Ohio Department of Transportation.

SECTION 4. That the Village of Genoa agrees to hold the Director of Transportation, and the Ohio Department of Transportation harmless for any claim or dispute arising out of participation in a contract pursuant to Ohio Revised Code Section 121.22 of the Ohio Revised Code.

SECTION 5. It is hereby found and determined that all formal actions of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6. The passage of this Ordinance is hereby declared to be an emergency measure necessary for the public peace, health, and safety of said Village.

SECTION 7. This Ordinance shall be in full force and effect from and immediately after its passage.
