## ORDINANCE 10-2018

**AN ORDINANCE AWARDDING A BID TO B HILL'Z EXCAVATING, INC. 8085 McCUTCHEVILLE RD. WAYNE, OHIO 43466 FOR THE AMOUNT OF (\$307,267.00) FOR THE VILLAGE OF GENOA'S PHASE 3 WASHINGTON STREET RECONSTRUCTION PROJECT AND DECLARING AN EMERGENCY.**

WHEREAS, the Village of Genoa did authorize the Village Administrator to advertise for bids for the Washington Street Phase 3 Reconstruction Project.

WHEREAS, B Hill'z Excavating, Inc. 8085 McCutchenville Rd. Wayne, Ohio 43466 was the lowest and best bid.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby award a bid to, B Hill'z Excavating, Inc. 8085 McCutchenville Rd. Wayne, Ohio 43466 in the amount of \$307,267.00

SECTION 2. That the Village Administrator is hereby authorized to enter into, and execute a contractual agreement with B Hill'z Excavating, Inc. 8085 McCutchenville Rd. Wayne, Ohio 43466 for the Phase 3 Washington Street Reconstruction Project.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. The passage of this ordinance as an emergency measure is necessary for the immediate preservation of the public peace, health, and safety of said Village. This ordinance shall be in full after its passage.


