

# RECORD OF ORDINANCES

## ORDINANCE 11-2020

### **AN ORDINANCE AMENDING TAX ORDINANCE 09-2018, SECTION 181.013 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF GENOA, FOR ALLOCATION OF FUNDS; AND DECLARING AN EMERGENCY**

**WHEREAS**, Ordinance 09-2018 was passed on 3/19/2018 wherein Section 181.013 prescribed that income tax funds received were to be allocated as follows:

General Fund (101)	82.5%
Capital Improvement Fund (403)	17.5%

**WHEREAS**, the Village has recently updated the financial reporting system; and

**WHEREAS**, Council desires to amend the allocation formula to meet future financial obligations of the Village, in accordance with recommendation of the Auditor of the State, Financial Reporting;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:**

**SECTION 1.** That this Council hereby amends Section 181.013 and Ordinance 29-2018, and directs the Fiscal Officer commencing January 1, 2020 as follows:

To allocate from the Villages General Fund of income tax collected,

33% to Capital Improvement Fund (4901)  
67% to General Fund (101)

**SECTION 2.** That all other provisions of pertaining to Chapter 181 of the Village Codified Ordinance not herein amended shall remain in full force and effect.

**SECTION 3.** It is found and determined that all formal actions of Council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

**SECTION 4.** That this Ordinance constitutes an emergency measure because changing the allocation of funds to meet future financial obligation of the Village is necessary to preserve the public peace, safety, and welfare of our citizens. This ordinance shall be in full force and effect immediately after its passage by the Mayor.
