

# RECORD OF ORDINANCES

## ORDINANCE 11-2023

**AN ORDINANCE AGREEING TO COOPERATE FOR THE PURPOSE OF PROVIDING OUTDOOR RECREATION IMPROVEMENTS; AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of Genoa, Ohio desires to utilize funding available through the 2023 Park District of Ottawa County Parks and Trails Improvement Grant Program;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:**

**SECTION 1.** That the Council of the Village of Genoa, Ottawa County, Ohio agrees to cooperate for the purpose of increasing and improving outdoor recreation opportunities under the terms and conditions of the "2023 Parks and Trails Improvement Grant Program" administered by the Park District of the Ottawa County Board of Park Commissioners.

**SECTION 2.** That the Council of the Village of Genoa authorizes the Village Mayor Thomas E. Bergman to apply to the Park District of Ottawa County Board of Park Commissioners for funding assistance from the "2023 Parks and Trails Improvement Grant Program.

**SECTION 3.** That is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This ordinance shall take effect as an emergency measure necessary because timely application to secure funding assistance for programs that benefit Village residents, protects the health, safety and welfare of our citizens and shall be in full force from and immediately after its passage.
