ORDINANCE NO. 16-2023

AN ORDINANCE ADJUSTING AND REDISTRIBUTING THE PAYMENT OF THE VILLAGE ADMINISTRATOR SALARY AND BENEFITS AMONG VARIOUS VILLAGE FUNDS. (FIRST READING)

WHEREAS, The Village Administrator's duties encompass substantial efforts within several different departments; and

WHEREAS, the Village council wishes to adjust and redistribute the Village Administrator's annual salary and benefits among various funds within several different departments;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That effective April 1, 2023 the Village Administrator's annual salary and benefits shall be adjusted and redistributed from funds as follows:

1000-710-131	Administrative (General Fund)	33.5%
1000-410-131	Zoning (General Fund)	6.5%
2011-620-190	Streets	15%
5101-539-190	Water	15%
5201-549-190	Sewer	15%
5301-519-190	Electric	<u>15%</u>
		100%

SECTION 2. It is found and determined that all formal action of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

SECTION 3. That the passage of this Ordinance as an emergency measure is necessary to preserve the public peace, safety of said Village in order to comply with the established debt payment schedule.

SECTION 4. This Ordinance shall be in full force and effect immediately after it passage.
