## ORDINANCE 23-2021

AN ORDINANCE AWARDING A BID TO GEDDIS PAVING AND EXCAVATING OF, 1019 WAMBA AVE., TOLEDO, OHIO 43607, FOR THE RESURFACING OF VILLAGE STREETS, IN THE AMOUNT OF (\$231,405.25) FOR THE VILLAGE'S 2021 STREET RESURFACING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the Village Council did authorize the Village Administrator to advertise for bids for the 2021 Street Resurfacing Program.

WHEREAS, Geddis Paving and Excavating, of 1019 Wamba Ave., Toledo, Ohio 43607 was the lowest and best bid.

WHEREAS, The Village Engineer, CT. Consultants of Toledo, Ohio, does recommend the bid award.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby award a bid to Geddis Paving and Excavating, of 1019 Wamba Ave., Toledo, Ohio 43607, in the amount of (\$231,405.25)

SECTION 2. That the Village Administrator is hereby authorized to enter into and execute a contractual agreement with Geddis Paving and Excavating of 1019 Wamba Ave., Toledo, Ohio 43607, for the 2021 Street Resurfacing Program.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. The passage of this ordinance as an emergency measure is necessary for the immediate preservation of the public peace, health, and safety of said Village. This ordinance shall be in full after its passage.
