

# RECORD OF ORDINANCES

## ORDINANCE 24-2018

AN ORDINANCE AMENDING ORDINANCE #19-2017 TO READ; DISTRIBUTING THE PAYMENT OF THE VILLAGE ADMINISTRATOR'S / ZONING ADMINISTRATOR'S SALARY AND BENEFITS AMONG VARIOUS VILLAGE FUNDS; AND DECLARING AN EMERGENCY.

WHEREAS, The Village Administrator's / Zoning Administrator's duties encompass substantial efforts within several different departments; and

WHEREAS, the Village council wishes to adjust and distributed the Village Administrator's / Zoning Administrators, annual salary and benefits among various funds;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That effective September 17, 2018 the Village Administrator's / Zoning Administrator's annual salary and benefits shall be adjusted and distributed from funds as follows:

101 Zoning	5%
101 Administration	30%
201 Streets	15%
601 Water	25%
602 Sewer	15%
603 Electric	<u>10%</u>
	100%

SECTION 2. It is found and determined that all formal action of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance constitutes an emergency measure because adjusting and redistribution of funds used for the compensation of the Village Administrator is necessary for the immediate preservation of the public peace, safety, and welfare of our citizens. This ordinance shall be in full force and effect immediately after its passage by the Mayor.




