ORDINANCE 27-2021

AN ORDINANCE PROVIDING FOR SEWER ASSESSMENTS UPON LOTS AND LANDS IN THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO, FOR THE 2021 TAX YEAR; AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO:

SECTION 1. That to pay for Sewer Assessments in the Village of Genoa, Ottawa County, Ohio, shall be assessed upon lots and lands as described herein, for the year 2021, as may be determined by the Ottawa County Auditor to produce the sums as indicated from the lands listed below:
