

# RECORD OF ORDINANCES

## ORDINANCE 27-2022

### **AN ORDINANCE AGREEING TO COOPERATE FOR THE PURPOSED OF PROVIDING OUTDOOR RECREATION IMPROVEMENTS AND DECLARING AN EMERGENCY.**

WHEREAS, the State of Ohio through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes, through the State of Ohio NatureWorks grant program and

WHEREAS, the Village of Genoa desires financial assistance under the NatureWorks Grant Program,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That the Council of the Village of Genoa, Ottawa County, Ohio agrees to cooperate for the purpose of increasing and improving outdoor recreation opportunities under the terms and conditions of the NatureWorks Grant Program.

SECTION 2. That the Council of the Village of Genoa authorizes the Village Administrator to file an application to the Ohio Department of Natural Resources for funding assistance from the NatureWorks Grant Program and to provide all information and documentation required to become eligible for possible funding assistance, and to execute the grant agreement should funds be awarded.

SECTION 3. That the Council of the Village of Genoa does agree to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms of the NatureWorks Grant Program.

SECTION 4. That is found and determined that all formal actions of Council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and Section 121.22 of the Ohio Revised Code.

SECTION 5. This ordinance shall take effect as an emergency measure necessary because timely application to secure funding assistance for programs that benefit Village residents, protects the health, safety and welfare of out citizen and shall be in full force from and immediately after its passage.
