ORDINANCE 31-2018

AN ORDINANCE AMENDING SECTION 531.06 REMOVAL OF WEEDS; NOTICE; COSTS OF THE CODIFIED ORDINANCE'S OF THE VILLAGE OF GENOA.

WHEREAS, it has been determined to establish a fee of a minimum cost of one hundred twenty five dollars (\$125.00) up to the first hour, and one hundred twenty five dollars (\$125.00) per/hour thereafter, Prorated at half-hour intervals for non-compliance of section 531.06 of the codified.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO:

SECTION 1. That this council of the Village of Genoa, Ottawa County does hereby amend section 531.06 Removal of Weeds; Notice and costs of the Codified Ordinance to read as follows:

531.06 Removal of Weeds; Notice; Costs

(e) A minimum fee of one-hundred twenty-five dollars (\$125.00) up to the first hour, and one-hundred twenty-five dollars (\$125.00) per/hr. thereafter, prorated at half hour intervals for non-compliance.

(f) That after the first notice within the same year to cut weeds in accordance to Section 531.06 of the Ohio Revised Code that the second notice shall have a Twenty-five dollars (\$25.00) penalty notice; the third notice shall carry a Fifty dollars (\$50.00) penalty notice, and a fourth notice the Police Department shall issue a citation with a penalty of no more than three hundred dollars (\$300.00).

SECTION 2. All other provision of Section 531.06 not herein amended shall remain in full force and effect.

SECTION 3. It is hereby found and determined all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this council and that all deliberations of this Council or of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. This ordinance shall take effect at the earliest date allowed by law.
