ORDINANCE 34-2018

ORDINANCE APPROVING THE RECODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF GENOA, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Genoa, Ohio;

WHEREAS, numerous sections of the Traffic, General Offenses and Fire Prevention Codes need to be updated to comply with State law;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, STATE OF OHIO:

SECTION 3. The complete text of the Traffic and General Offenses Codes sections listed above are set forth in full in the 2018 replacement pages to the Codified Ordinances which are hereby attached to this ordinance as Exhibit A. Any summary publication of this ordinance shall include a complete listing of these sections. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

SECTION 4. It is found and determined all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Ohio Revised Code Section 121.22.

SECTION 5. This ordinance is hereby declared to be an emergency measure in the interest of public peace, health and safety because it is imperative for the officers, employees and citizens of the Village that the Codified Ordinances be updated as soon as possible in order to avoid confusion and legal entanglements; and shall, therefore, go into immediate effect upon its passage.




