ORDINANCE #37-2022

ORDINANCE AUTHORIZING THE FISCAL OFFICER TO ISSUE A THEN AND NOW PURCHASE ORDER TO GEDDIS PAVING AND EXCAVATING CO. AND THE OTTAWA COUNTY COMMISSIONERS; AND DECLARING AN EMERGENCY.

WHEREAS, an order was made to Geddis Paving and Excavating Co. for the 2022 Paving Project on April 5, 2022 in the estimated amount of \$249,060.95; and

WHEREAS, an order was made to the Ottawa County Commissioners for expenses incurred for the North Coast Inland Trail on July 22, 2022 in the amount of \$9,979.00;

WHEREAS, the Auditor of the State requires a Then and Now purchase order over \$3,000.00 to be approved by Council during formal session;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO THAT:

SECTION 1. That the Fiscal Officer shall issue a Then and Now purchase order to Geddis Paving and Excavating Co. for the sum of \$249,060.95 for the 2022 Paving Project.

SECTION 2. That the Fiscal Officer shall issue a Then and Now purchase order to the Ottawa County Commissioners for the sum of \$9,979.00 for expenses incurred for the North Coast Inland Trail.

SECTION 3. It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and Section 121.22 of the Ohio Revised Code.

SECTION 4. This ordinance shall take effect as an emergency measure necessary because proper accounting and payment of expenses in the Village helps protect the health, safety and welfare of our citizens and shall be in full force from and immediately after its passage.
