

RECORD OF ORDINANCE

ORDINANCE # 04-2022

AN ORDINANCE ESTABLISHING FUND NO. 2152 TO DEPOSIT, ACCESS AND APPROPRIATE FUNDS RECEIVED UNDER THE AMERICAN RESCUE PLAN ACT (ARPA); AND DECLARING AN EMERGENCY.

WHEREAS, The Village of Genoa was awarded funds under the American Rescue Plan Act:

NOW THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE VILLAGE OF GENOA, OHIO, AS FOLLOWS:

SECTION 1: Under direction from the Auditor of the State, the Village Fiscal Officer shall create Fund No. 2152 for the deposit and access of the A.R.P.A funds and transfer the funds from Fund No. 2151. That the Fiscal Officer is authorized to create line items for the appropriations of necessary expenditures therefrom. That the transfer and deposit shall be retroactive to January 1, 2022.

SECTION 2: The following 2022 Temporary Appropriations for Fund No 2152 be made:

2152-800-431 Repairs and Maintenance	\$1,000.00
2152-800-530 Buildings	\$25,000.00
2152-800-540 Equipment & Furniture	\$20,000.00
2152-800-560 Utility Distribution System	\$50,000.00

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.

SECTION 4: This Ordinance constitutes an emergency as the proper allocation of funds is necessary to promote the health, safety and welfare of our citizens. This ordinance shall be in full force and effect immediately after its passage by the Mayor.




