ORDINANCE 44-2019

AN ORDINANCE AUTHORIZING THE FISCAL OFFICER OF THE VILLAGE OF GENOA, OHIO TO MAKE SUPPLEMENTAL APPROPRIATIONS TO THE 2019 PERMANENT APPROPRIATIONS AND DECLARING AN EMERGENCY.

WHEREAS: The Fiscal Officer has reviewed the 2019 permanent appropriation accounts and determined the need to make supplemental appropriations for the purchase of a New Ford F-250 truck.

SECTION 1: That the appropriation increases and decreases are made as follows:






