

RECORD OF ORDINANCE

ORDINANCE NO. 46-2022

ORDINANCE PROHIBITING PARKING ON THE 800 BLOCK OF WEST STREET, GENOA, OHIO, ON WEEKDAYS BETWEEN 7A.M. AND 5P.M.; AND DECLARING AN EMERGENCY.

WHEREAS, the Administration of the Village of Genoa has received numerous complaints regarding parking on West Street in the Village of Genoa; and

WHEREAS, Council has been advised by the Chief of Police of various safety issues necessitate the limiting of parking on the 800 block of West Street; and

WHEREAS, Council believes that limiting parking on the 800 block of West Street is necessary for safety purposes;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OHIO:

Section 1. That parking is prohibited in the 800 block of West Street, Genoa, Ohio between the hours of 7:00 a.m. until 5:00 p.m. on weekdays. That violation of the Ordinance shall be considered a minor misdemeanor.

Section 2. That upon passage of the Ordinance the Village shall post appropriate signage on West Street; and further, shall notify the residents on the 800 block of West Street, of this Ordinance, by U.S. Mail.

Section 3. It is found and hereby determined that all formal actions of Council concerning or relating to the passage of this ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

Section 4. This ordinance shall take effect as an emergency measure because proper updating of the Village Traffic Code protects the health, safety and welfare of our citizens.


