## ORDINANCE 47-2019

**ORDINANCE AMENDING ORDINANCE 42-2019, AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN EQUIPMENT LEASE WITH THE FORD MOTOR COMPANY FINANCE FOR THE PURPOSE OF LEASING WITH AN OPTION TO PURCHASE A FORD F-250 TRUCK; AND DECLARING AN EMERGENCY.**

**WHEREAS**, Village Council approved the lease of a 2019 Ford F-250 truck pursuant to Ordinance 42-2019;

**WHEREAS**, the vehicle that the Village took delivery of, was a 2017 Ford F-250 truck;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO THAT:**

**SECTION 1.** That the Council of the Village of Genoa, Ottawa County, Ohio hereby authorizes the Village Administrator to enter into a Lease Agreement between the Village of Genoa and the Ford Motor Company Finance, in 3 Annual Payments for a 2017 Ford F-250 truck.

**SECTION 2.** It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This ordinance shall take effect as an emergency measure necessary because proper execution of a Lease Agreement to acquire proper equipment on behalf of the Village protects the health, safety and welfare of our citizens and shall be in full force from and immediately after its passage.






