ORDINANCE 09-2020

AN ORDINANCE AUTHORIZING THE DISPOSAL OF OBSOLETE SURPLUS PERSONAL PROPERTY OWNED BY THE VILLAGE, THROUGH INTERNET AUCTION AND UTILIZING 'GOVDEALS.COM AND MUNICIBID.COM' FOR 2020; AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Revised Code Section 721.15(D) authorizes the sale of unneeded, obsolete or unfit property by internet auction;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OHIO.

SECTION 1. That the Village Administrator is hereby authorized to contract with GovDeals.com and Municibid.com internet auction site for the disposition of unneeded, obsolete or unfit property for 2020. The Village Administrator is authorized to establish the general terms and conditions of sale including number of days for bidding on the personal property which shall be no less than 10 days.

That this Ordinance, once adopted, shall be published twice in the newspaper of general circulation with the second notice published not less than 10 nor more than 20 days after the first publication.

SECTION 2. That is it found and determined that, to the extent required by law, all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and of any its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

SECTION 3. That this Ordinance constitutes an emergency measure because the proper disposal of unneeded, obsolete or unfit property owned by the Village is necessary for the immediate preservation of the public peace, safety, and welfare of our citizens. This ordinance shall be in full force and effect immediately after its passage by the Mayor.
