

# RECORD OF ORDINANCES

## ORDINANCE #9-2022

### ORDINANCE AMENDING WAGE AND SALARY SCHEDULE ESTABLISHED BY ORDINANCE #70-2017 FOR ALL VILLAGE EMPLOYEES, MAYOR AND VILLAGE COUNCIL AND DECLARING AN EMERGENCY.

**WHEREAS**, the Genoa Village Council wishes to update all wage and salary ordinances for all Village employees, Mayor and Village Council; and consolidate them into one Ordinance, repealing all other Ordinances pertaining to wages and salary levels of all Village employees, Mayor, and Village Council, and

**WHEREAS**, the Genoa Village Council wishes to provide equitable wage and salary levels for all employees of the Village of Genoa,

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:**

**SECTION 1.** That Genoa Village Administrator shall set the pay rates and work hours for officials and employees pursuant to the following schedule:

Seasonal Grounds Keeper	\$10.00 - \$15.00 per hour

In no case shall the expenditures for salaries exceed the amount appropriated for each fund by the Village Council

**SECTION 2.** Police Department may employ four (4) part-time patrolmen, per Ordinance #51-2017. Work hours are per Ordinance #28-2008.

**SECTION 3.** All previous ordinances pertaining to wage and salary levels as provided herein above shall be repealed.

**SECTION 4.** It is found and determined that all formal actions of Council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and the State of Ohio.

**SECTION 5.** That this Ordinance shall take effect at the earliest date allowed by law.
