Ordinance 49-2017

AN ORDINANCE AUTHORIZING THE FISCAL OFFICER TO TRANSFER TWO THOUSAND SEVEN HUNDRED FIFTY SIX DOLLARS (\$2,756.00), FROM WATER FUND (601), THE SEWER FUND (602), AND THE ELECTRIC FUND (603), INTO THE EQUIPMENT DEBT FUND AND DECLARING AN EMERGENCY.

WHEREAS, the Village has debt payment due KS StateBank for the purchase of the 2016 Volvo truck used in the Utility Department..

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby authorize the Fiscal Officer to transfer from each fund; Water Fund (601), Sewer Fund (602), and Electric Fund (603), to the Equipment Debt Fund (305), as follows:

From: Water Fund	601.910.5910	\$2756.00
Sewer Fund	602.910.5910	\$2756.00
Electric Fund	603.910.5910	\$2756.00
To: Equipment Debt Fund	305.810.4191	\$8268.00

SECTION 2. It is found and determined that all formal actions of Council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.





