AN ORDINANCE AUTHORIZING THE FISCAL OFFICER OF THE VILLAGE OF GENOA, OHIO TO SUPPLEMENT THE 2023 PERMANENT APPROPRIATIONS; AND DECLARING AN EMERGENCY.


