## ORDINANCE 62-2023

ORDINANCE CONSENTING TO THE EXPEDITED TYPE 2 ANNEXATION FILED BY ATTORNEY ERNEST E. COTTRELL, JR. ON BEHALF OF PHILLIP SCHOBBER, PHILLIP D. SCHOBBER AND SCHOBBER RENTALS NO. 2 LLC; AND DECLARING AN EMERGENCY.

WHEREAS, on September 15, 2023, a Petition was filed for the Expedited Type 2 Annexation for the real property currently located in Clay Township, Ottawa County, Ohio and fully described in attached Exhibit A, consisting of approximately 230.911 acres of land, located south of State Route 163; and

WHEREAS, the Village of Genoa consents to the Annexation into the Village of Genoa; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO THAT:

**SECTION 1.** That the Council of the Village of Genoa, Ottawa County, Ohio hereby *CONSENTS* to the Expedited Type 2 Annexation of the real property described in Exhibit A into the Village of Genoa, Ottawa County, Ohio.

**SECTION 2.** It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This ordinance shall take effect as an emergency measure necessary because allowing economic growth in the Village helps protect the health, safety and welfare of our citizens and shall be in full force from and immediately after its passage.


