ORDINANCE 65-2023

AN ORDINANCE AWARDING A BID TO GEDDIS PAVING AND EXCAVATING OF, 1019 WAMBA AVENUE, TOLEDO, OH 43607, FOR THE CONSTRUCTION OF A MULTI-USE PATH AND TRAILHEAD IMPROVEMENTS, IN THE AMOUNT OF (\$112,163.00) BASE BID AND (\$14,270.00) ALTERNATE BID FOR THE COMBINED TOTAL OF (\$126,433.00) FOR THE VILLAGE'S GENOA NORTH COAST INLAND TRAIL EXTENSION PROJECT; AND DECLARING AN EMERGENCY.

WHEREAS, the Village Council did authorize the Village Administrator to advertise for bids for the Genoa North Coast Inland Trail Extension, Project Number RT21 (405); and

WHEREAS, Geddis Paving and Excavating, of 1019 Wamba Ave., Toledo, Ohio 43607 was the lowest and best bid.

WHEREAS, The Village Engineer, CT Consultants of Toledo, Ohio, does recommend the bid award.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GENOA, OTTAWA COUNTY, OHIO THAT:

SECTION 1. That this Council of the Village of Genoa, Ottawa County, Ohio does hereby award a bid to Geddis Paving and Excavating, of 1019 Wamba Avenue, Toledo, OH 43607, in the total amount of (\$126,433.00).

SECTION 2. That the Village Administrator is hereby authorized to enter into and execute a contractual agreement with Geddis Paving and Excavating of 1019 Wamba Avenue, Toledo, OH 43607, for the Genoa North Coast Inland Trail Extension Project.

SECTION 3. It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Genoa and Section 121.22 of the Ohio Revised Code.

SECTION 4. The passage of this ordinance as an emergency measure is necessary to encourage the contractor to begin construction during the 2023 season. This ordinance shall be in full after its passage.


